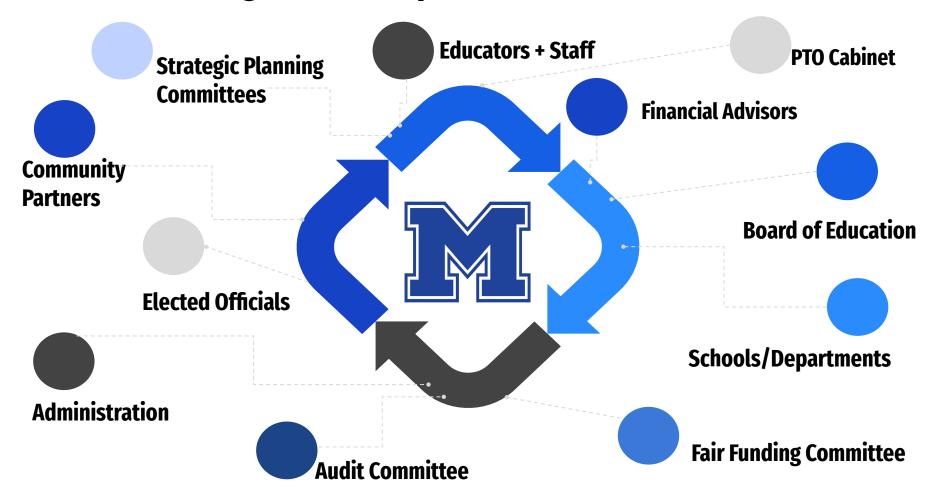


Mission Statement

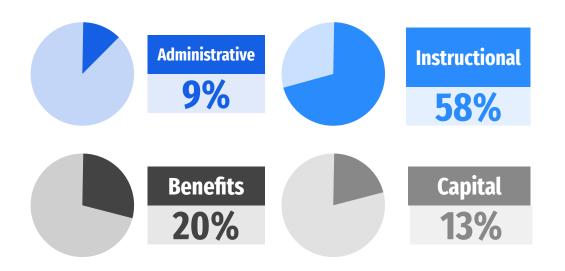

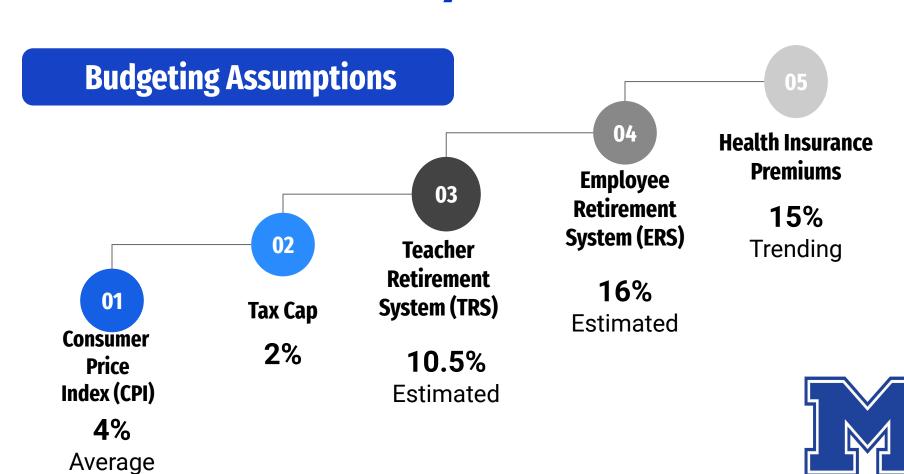


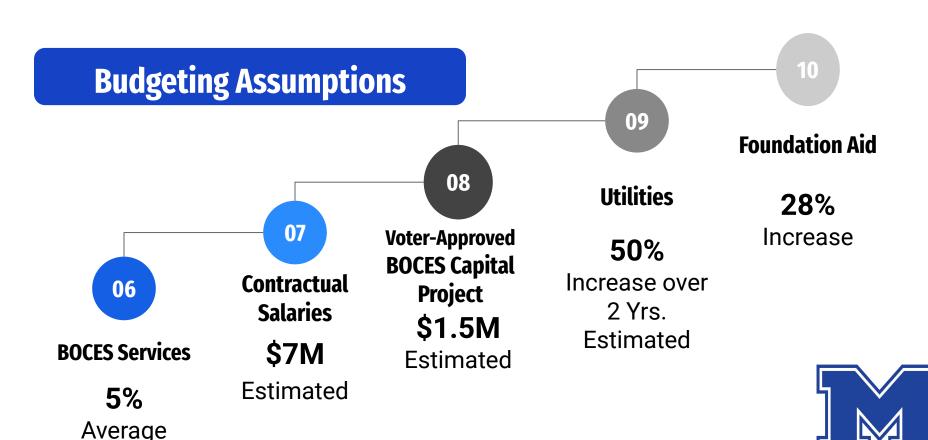
